To preserve your warranty rights, all **ISB™** products must be installed in accordance with the then-current Installation Instructions available at [www.innovativetilesystems.com](http://www.innovativetilesystems.com).

To exercise your rights for any alleged defective product under this Manufacturer's Limited Warranty, you must contact your ITS reseller for return authorization and other instructions, and must ship this product to such reseller in appropriate packaging at your expense, together with a photocopy of your receipt or other valid proof of purchase. ITS does not accept shipments from purchasers, and all product warranty returns must be initiated with and through your reseller within 10 days following expiration of the one year Manufacturer's Limited Warranty period.

As its sole and exclusive remedy for warranty claims, ITS will replace defective products, provided that such product damage did not occur as a result of improper storage, handling or installation; alteration or other abuse or misuse; abnormal service; or any damage which may have been caused either directly or indirectly by another product.
